

As of January 1, 2014, mental health counselors, psychologists, marriage and family therapists, licensed social workers, *certified counselors and *certified advisors, *chemical dependency professionals, and occupational therapists MUST participate in a 6-hour CE approved/accredited training seminar on Suicide Assessment, Treatment & Management within the next 2-3 years and then again every 6 years.
